

# Notice of Election

## Parliamentary Election for the **St Neots & Mid Cambridgeshire** Constituency

1. An election is to be held of a Member of Parliament for the St Neots & Mid Cambridgeshire Constituency.
2. Forms of nomination are available on request from the Acting Returning Officer, who will, at the request of an elector prepare a nomination paper for signature. Alternatively, a nomination paper may be downloaded (and printed) from the Electoral Commission website at [www.electoralcommission.org.uk](http://www.electoralcommission.org.uk).
3. Nomination papers must be delivered to the Acting Returning Officer at South Cambridgeshire Hall, Cambourne Business Park, Cambourne, Cambridge, CB23 6EA, on any day after the date of this notice between the hours of 10am and 4pm but no later than 4pm on Friday, 7 June 2024.
4. The required deposit may be made either in cash, by banker's draft or by bank transfer to an account nominated by the Acting Returning Officer.
5. If the election is contested the poll will take place on Thursday, 4 July 2024.
6. Applications to register to vote must be made by Tuesday, 18 June 2024. Apply via [www.gov.uk/register-to-vote](http://www.gov.uk/register-to-vote).
7. Applications, amendments or cancellations of postal votes and amendments or cancellations of proxy votes must reach your local Electoral Registration Officer at South Cambridgeshire District Council **or** Huntingdonshire District Council (as appropriate) by 5pm on Wednesday, 19 June 2024.
8. New applications to vote by proxy at this election must reach your Electoral Registration Officer at South Cambridgeshire District Council **or** Huntingdonshire District Council (as appropriate) by 5pm on Wednesday, 26 June 2024.
9. Applications to vote by emergency proxy at this election on grounds of physical incapacity or for work/service reasons must reach your Electoral Registration Officer at South Cambridgeshire District Council **or** Huntingdonshire District Council (as appropriate) by 5pm on Thursday, 4 July 2024. The physical incapacity must have occurred after 5pm on Wednesday, 26 June 2024. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5pm on Wednesday, 26 June 2024.
10. Applications for a Voter Authority Certificate must be made by 5pm on Wednesday, 26 June 2024.
