Fulbourn Parish Council held a Public Meeting on 7/3/2018. This had been widely advertised on the PC web site and notice boards and included in an edition of the "Pump", which is a quarterly news letter from the Parish Council delivered to each house in Fulbourn parish.

The meeting was well attended. Two of the speakers were Clir Robert Turner and David Roberts from SCDC who outlined the benefits of a Neighbourhood Plan and explained the procedures which had to be undertaken. A question and answer session then took place to answer any queries from the floor. Following this a vote by show of hands was taken and it was agreed to start the procedure to prepare a Neighbourhood Plan. The vote to agree to prepare a Neighbourhood Plan was subsequently endorsed by the Parish Council at the PC meeting held on 14/3/18.

The Fulbourn Forum, which has wide membership through the village and the Trust which is responsible for operating the Fulbourn Centre have agreed to lead the initiative supported by the Parish Council. The membership of the Forum and the users of the Centre have all been circulated seeking volunteers etc.

An article has been placed in the village magazine and a display is planned for the Fulbourn Feast which is scheduled for late June. Another meeting of the Steering Group is scheduled for late May and again has been widely trailed.
