2.4 What are the headline aims of the proposal and the objectives that will help to accomplish these aims? (Max 250 words)

South Cambridgeshire District Council (SCDC) carried out a four-day week pilot (4DW) between January 2023 and the end of March 2024. Four-day week working has continued at the Council since the end of the trial period. As part of the decision-making process to decide on the future of the 4DW for officers employed by the Council, the Council has committed to carrying out a consultation. This consultation will be carried out digitally. It will aim to understand if and/or how respondents' experience with Council services has been impacted by the 4DW, as well as respondents' views on the 4DW itself. As part of the consultation there will be three separate surveys, which will run for eight weeks:

- 1. A targeted external survey to meet our Best Value Duty requirements
- 2. A general external survey of residents and businesses
- 3. Statistically valid survey of residents and businesses

Alongside these surveys, internal staff views will also be collated.

This EqIA will specifically be looking at the process behind the consultation, rather than the options being put forward within the consultation itself, with the proposed options being subject to a separate EqIA. This is to ensure that the proposed method of consultation is appropriate for all groups and that the consultation is capturing as many responses from as many groups as possible, allowing any future decision on the Council's approach to recruitment and retention to be fully informed. As such, the proposed consultation takes a range of measures to maximise the ability of people to respond, such as providing physical copies of the consultation, making sure that any system used to gather responses is fully accessibility compliant, and continuous equalities monitoring.

The public's ability to be heard during consultation relies on their ability to respond. When individuals and groups are unable to respond, for whatever reason, the consultation risks not accurately capturing the full range of public opinion. This ultimately undermines the validity of any final decision made as a result of the consultation, as well as increasing the possibility of unintended negative consequences towards potentially already vulnerable groups. As such, it is the Council's responsibility to ensure that we are not inadvertently disenfranchising any groups by accidentily creating barriers to response and we should take actions that reflect the significance of council decision making on our residents and service users.

There will be up to two external partners involved in the 4DW consultation process, though these have yet to be appointed. These external partners will be involved in:

- 1. The creation and delivery of a statistically valid survey.
- 2. The independent analysis of the data collected as part of the consultation exercise.

There is potential for one company to complete both tasks, but this would be explored as part of the procurement exercise. Additionally, as part of this same procurement exercise, we will ensure that companies are aware of their requirements to act in line with the Equality Act (2010) and will encourage them to monitor their own equalities impact. Furthermore, should any issues around the suppliers approach to equalities be raised, we will act accordingly to ensure that they continue to be aligned to the Council's equalties values.

Additionally, the digital surveys, which will be carried out as part of the consultation, will be hosted on the third-party consultation platform GoVocal. This platform is fully compliant with WCAG 2.2 accessibility standards and will help us to better engage with, and monitor our engagement with, our residents and businesses, including underrepresented groups.

To ensure that the consultation design was robust, it was decided that a consultation expert would be appointed to support with process design, including with any equalities-based queries. General equalities advice has

also been sought from the Council's Policy and Performance Officers who have previous experience with reviewing proposed consultation processes and have advised on where we can improve our process. Additionally, stakeholder mapping has also been carried out, allowing us to identify potential barriers to engagement for groups which we may need to resolve.

Details: The way in which we present our questions forms an important part of how or if people respond. Should questions be overly technical or written in a way which the general public find difficult to engage with, we are likely to receive responses that don't accurately answer the questions being asked or we will receive a more limited range of responses. To limit this risk and ensure that groups feel confident in



responding, the Council will be carrying out structural validity testing before the consultation goes live in order to ensure that the proposed questions are understood as intended.

Furthermore, the consultation will be written to ensure that it is able to be understood by a general audience. To ensure this is the case, the full consultation – including the introduction - will seek to achieve a Flesch-Kincaid Score which is as low as possible, indicating a low reading age. This reflects government guidance that digital content should be written with a reading age of nine, in line with the national average reading age. By doing so, we will allow more people to fully engage with the consultation in a way that is meaningful.

Finally, as part of our Best Value duties, we will be engaging with representative groups for underrepresented characteristics (such as Cambridge Council for Voluntary Services, Age UK etc.). This will help drive up engagement with these groups and will allow us to ensure that we are providing a full range of view points to decision makers.

⊠Age

Details: It is acknowledged that older adults are more likely to struggle to engage with consultations carried out within a digital space, with 20% of households with one adult aged 65 or over not having an internet connection, with 23% of older adults using the internet less than weekly or not at all within the last three months (ONS, 2020). Additionally, Age UK (2023) found that among people aged 65 and over, 1 in 5 were unable to fill in forms online. As such, it is important the Council makes effort to ensure that they are not excluded. This is detailed in the section on Digital Inclusion further down the document. It is also important to note that these issues are not limited to older adults, and that younger people also have barriers to accessing digital content even if they have the technical skill to do so, as revealed during the COVID-19 Pandemic.

⊠Disability



Details: Within South Cambridgeshire, 14.8% of individuals identify as disabled under the Equality Act (Census, 2021). To ensure that individuals with disabilities are able to access our digital content should they so wish, all digital content will be to WCAG 2.2 accessibility standards. Additionally, alternative forms of engagement with the consultation will be provided to allow as many people as possible to successfully engage with us. This will include the provision of physical copies on request (that can be made into large text versions if needed), and assisted completion of the consultation by the contact centre if needed. This will also apply to the internal staff survey.

⊠Race

Details: Additionally, language plays a significant part in if people can reply. According to the 2021 Census, the majority of residents within South Cambs (93.20%) speak English as their first or preferred language, with Polish (0.73%), Romanian (0.46%), Spanish (0.45%), and Italian (0.38%) making up the rest of the top five. In total, there are an estimated 30 languages where over 100 people have identified it is their preferred language. Additionally, due to the fact the census data provides a snapshot at the point at which it is collected, there are likely to be some instances of under-reporting. For example, only 21 individuals reported their first or preferred language to be Ukrainian during the 2021 Census. However, due to the onset of the Ukraine War in 2022, the Ukrainian speaking population of South Cambridgeshire has grown significantly – with South Cambs taking on over 900 Ukrainian refugees since the census was completed. To ensure that everyone is able to respond, the Council will make available translated documents upon request, working with our translation partner AA Global Services to make these available.



Additionally, our digital consultation platform, GoVocal, has in-built translation capabilities to empower individuals to digitally respond where possible.

4.2 Other characteristics

Some characteristics are not yet protected in law, but the Council has made declarations it will consider them in policy making.

Digital inclusion (what is this?)

Details: The Council recognises that measures are needed to ensure that running a digital-first consultation does not alienate groups. Whilst the number of adults described as "internet non-users" has been decreasing steadily over recent years (ONS, 2019), a report by OFCOM in 2022 found that the number of households without access to the internet was around 6%, with access to the internet not being the only factor contributing to digital exclusion. Of those without access to the internet at home, the groups that are most likely to be affected are those aged 75 or over (26%), those in the DE socio economic classification (i.e., semi-skilled, unskilled, or casual workers or those on state benefits only; 14%), and those who are out of work (13%). This is important to recognise as the individuals within these categories are more likely to need to engage with some Council services.

To ensure that all residents can engage meaningfully with the process, hard copies



of any digital content will be provided on request. This will be available to collect from South Cambs Hall or can be sent out to residents or businesses via post. Additionally, paper copies of the internal staff survey will be made available at the Depot. This is because Waste Operatives do not have a Council email address and therefore are more likely to be digitally excluded.

 \boxtimes Rurality

Details South Cambridgeshire is largely a rural district, consisting of over 100 villages. By running the consultation online, this allows individals from more rural locations to engage with consultation as they do not have to travel to physical locations to do so. Whilst internet access in more rural areas is slower than that of urban areas, only 0.9% of rural households across England do not have access to decent broadband (DEFRA, 2020). As such, the negative impact of a digital-first consultation should be minimal in terms of poor digital access caused by rurality and any negative impact is inherently offset by the efforts outlined in the digital inclusion section above.
