## Tesco stand responses:

Having walked round there for 8years plus now I can say that conversations I have with others as they walk their dogs or just escape from life for a bit are VERY similar. To lose that space would be TERRIBLE for the wellbeing of so many. If the school is built there I think it would be FABULOUS to maintain a hefty space around it for the children to appreciate a bit of NATURE/SPACE and CALM away from busy roads and traffic noise, plus Carbon Monoxide from traffic pollution. We are SO lucky in these villages to have so many fabulous people who are keen to support our dwindling natural environment and seeing as the A14 will pump-out more CO than I can bare to think about, the provision of LOCAL GREEN SPACES at the other end of the village is clearly ESSENTIAL.
